1. Amber brought to the commissions attention that Hillary had originally wanted it to be renamed The Kidd-Lee Center, removing 'Woodland' from the name entirely. Lexie explained that when Amber originally submitted the letter on behalf of Hillary to the Parks & Recreation office, she was advised that the name Woodland

should be worked into the renaming if possible. The letter of recommendation was revised to have the name be the Woodland Kidd-Lee Center, if keeping Woodland is a necessity. The commission suggested the name be changed to Kidd-Lee Center at Woodland Park. If the building passes onto the renaming process, Local Child Care Planning Council will absorb any costs to provide new signage. The LCCPC would also like to do a ribbon cutting ceremony recognizing Gussie Kidd, Jacki Lee and the renaming of the building. Catherine makes a motion to rename the Woodland Hall to the Kidd-Lee Center at Woodland Park, (S) Stacie Dayhoff. Motion carries unanimously.
