1. SSTAC Meeting called to order by Jeannie Morvay-Clayton at 8:03 AM.
2. Introductions and a Determination of a Quorum were made.
3. SSTAC currently has four vacancies.
4. Notice of Meeting and Notice of Vacancies advertised in the local newspaper, letters mailed out to SSTAC interested parties mailing list, notices published on county websites, and posted at county buildings.
5. Tina McLaughlin moved to accept the Draft minutes from October 25, 2023, Rachel Nabors seconded the motion with all members in concurrence.
6. Rachel Nabors moved to accept the annual report with name change for Tina Gavette to Tina McLaughlin, Erick Hanneman seconded the motion with all members in concurrence.

7. Erick Hanneman and Rachel Nabors spoke about a possible Unmet Transit Need that the annual TDA Funds could cover starting in FY 2024-25. Transit has found a new transit routing and ride reservation system that would benefit County Transit riders. The requested increase in annual TDA Funds to Transit would be used for software subscription fees, software updates, and ongoing staff and passenger training. (This item will be included in our annual Unmet Needs Hearing.)

Further Transit updates were given about the possibility of expanded hours pending increased staff, billing for medical rides, increase advertising for Yosemite West are to include placing ads in Yosemite Express Paper, free trips to Sonora Farmer's Market have been added to the Transit offerings, planned driver located at the new HHSA extension office in North County to increase availability in that area, expecting the arrival of one new SUV in May and two new Ford Transit vans possibly in June, expected launch of the new routing and ride reservation system is June 2024.

8. Tina McLaughlin suggested that Transit partner with the Senior Center when doing the training for the new routing and ride reservation system.
9. SSTAC Meeting adjourned at 8:43 AM. Next meeting will be October 2024 date/time TBD.
