Was requested to review the audio of the 6-10-2024 minutes to verify last paragraph of Item G – Reversion Clause. Audio minutes were reviewed, and Item G final paragraph is correct.

- Question was asked, base off the discussion of Hanger leases will the county guarantee they will not non-renew? Wants the issue re-enforced and included in the minutes.
- Answer by Public Works Deputy Director Sam Cervený, the county cannot make a guarantee that 10yr. leases will not be non-renewed, however the county reserves the right in the future. The County cannot guarantee because no one knows what the future holds. However, there is no plan to non-renew leases.

Not sure where the issue of non-renewal is coming from as the County has reviewed the purchase of all hangers that have become avail. And those hangers were not a good fit. However, the County currently had the funds avail through ARPA when hanger 52 became avail. for sale and it was a good fit. This was not a non-renewal.

- Question restated – so there is no plan and there has been no discussion or alluded to non-renewal of leases and there has been no discussion of purchasing all private hangers. Because we have heard there has been.

- Public Works Deputy Director Sam Cervený – No never had a conversation about or alluding to non-renewal of hangers. The airport doesn't even have the money to purchase all the hangers.
- Answered again, and restated by Director Hansen, the County has no intentions of non-renewal. The money to purchase hanger #52 has been avail. for about 2 yrs, however the previous hangers were not a good fit.
