- 2. Approval of Minutes:** Minutes of November 18, 2020

- 3. Public comments - none**

- 4. Presentation:** LeRoy Westerling provided slideshow titled “Pyregence Consortium Overview: Fire modeling for California’s Fifth Climate Assessment”. Their research initiatives incorporate a variety of drivers in a suite of models that simulate extreme fire events on multiple spatial scales, time steps and time horizons for the state of California.

5. Discussion and Possible Action:

- a. Community Wildfire Protection Plan

CWPP accepting final comments December-January, then to Board of Supervisors in February.

- b. Ai4 Technologies Presentation

A few legal issues have come up, so it is stopped for now. The Grant with NSS is a problem for the County. Wondering if another organization wants to work with them on grant?

- c. FireSafe Regulations Changes/Update

Major changes coming to FireSafe regulations. Primarily upgrades and clarifies definitions on how roads can be constructed. It gives local jurisdictions the ability to modify regs for local need. Now requires reflective address signs. Improvements on water storage for new construction. Added Article 5 requiring fuel breaks and modifications on new developments AND requires them to be maintained. The County needs to map existing neighborhoods and communities for State reference by July 2021. Planning needs to identify gaps in current policies. Codes are triggered depending on type of construction.

- d. Education and Outreach – Ad Hoc Chair

Met on December 3rd to decide on a vision for this committee. They will be the communication link to the community. Facebook and links on existing pages will be utilized. Messaging ideas: Prescribed burn, fire prevention, fire extinguisher education video, using small tools correctly, fire landscaping, fire-proofing, and defensible space. RCD YouTube channel is available for use. Regular messaging is possible in the Gazette too. Meetings will be held the 1st Thursday of each month @ 9:30am.

- e. Project BOS Item/Action dates – update

MPUD delegated authority to Planning for Plan Review. Mariposa County Fire has MOU now, so they can work together. Fire and Life Safety inspections are now done locally. We need to add some seats and replace some vacancies on MCFAC. BOS approved big hotel project, called the Brown Bear project, with conference center and 96 residential units. .

Budget adopted and will be adjusted as TOT revenues come in.

County Fire: Jeremy Briese has been sworn in as new Sheriff. Takes affect December 29th.

Fire Safe Council: Foran CEQA is in Sacramento. Stumpfield project will start in January when contractor returns from wildfire response. Good progress on Firewise Community designation at Yosemite West, successful chipping and fuel breaks. Stoneridge Estates mobile home community had a massive fuels reduction of highly ignitable plants (juniper).

RCD: May be able to do a matching funds grant with Yosemite West.
