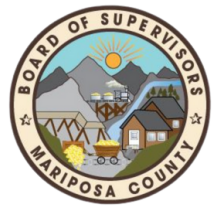

 - b. *All emails will be attached to the Minutes.*

2. E-Comment (requires an account and log in.)

- Go to the Board of Supervisors meeting page at <http://www.mariposacounty.gov/bosagendas>
- Log in. *(If you do not already have an account, you will need to first register for one by clicking on "Register" in the upper right corner of the page and then following the prompts.)*
- From the list of meeting dates, click on the correct meeting date. You will be presented with the agenda in an interactive format.
- Locate the description of the particular item on which you wish to comment, then click on the small e-Comment icon (two dialog bubbles) placed immediately after the description.
